RESOLUTION APPROVING SHARED SERVICES AGREEMENT WITH THE TOWNSHIP OF HOLMDEL FOR SHARED MUNICIPAL COURT SERVICES

WHEREAS, pursuant to N.J.S.A. 40A:65-1, et seq., any municipality of the State of New Jersey may contract with any other municipality for the shared provision of any service that any party to the agreement is empowered to provide within its own jurisdiction; and

WHEREAS, pursuant to N.J.S.A. 2B:12-1(c), two or more municipalities, by ordinance or resolution, may agree jointly to provide for courtrooms, chambers, equipment, supplies, and employees for their municipal courts without establishing a joint municipal court, commonly referred to as "Shared Municipal Court Services"; and

WHEREAS, with Shared Municipal Court Services, each Court retains its own identity, and the identities of the individual courts continue to be expressed in the captions of orders and process, per N.J.S.A. 2B:12-1(c); and

WHEREAS, Colts Neck has negotiated a shared services agreement with the neighboring municipality of the Township of Holmdel for the provision of Shared Municipal Court Services, upon the terms and conditions set forth in the shared services agreement attached hereto and incorporated by reference.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Colts Neck Township hereby approves entry into a shared services agreement with the Township of Holmdel for the provision of Shared Municipal Court Services, upon the terms attached hereto and incorporated by reference.

BE IT FURTHER RESOLVED that the Mayor is hereby authorized to execute the attached shared services agreement on behalf of the Township.

BE IT FURTHER RESOLVED that the Township Administrator is hereby authorized and directed to take any and all steps reasonably necessary to effectuate the foregoing.
