RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF HOWELL AUTHORIZING EXECUTION OF A SHARED SERVICE AGREEMENT BETWEEN THE TOWNSHIP OF HOWELL AND THE TOWNSHIP OF COLTS NECK

WHEREAS, Uniform Shared Services and Consolidation Act, *N.J.S.A. 40A:65-1 et seq.*, (the "Act") permits units of local government to share services for a particular purposes and to effectuate agreements for any service or circumstance that will aid and encourage a reduction of local expenses; and

WHEREAS, the Township Howell and the Township of Colts Neck are public bodies corporate and politic of the State of New Jersey and are authorized under New Jersey law to enter into a Shared Services Agreement pursuant to the Act; and

WHEREAS, the Township of Howell and the Township of Colts Neck desire to enter into a shared services agreement for the utilization of certain road equipment by Colts Neck Township; and

WHEREAS, representatives of Howell Township and Colts Neck Township have negotiated a Shared Services Agreement, a copy of which is annexed hereto as **Exhibit A**, and the terms of which are incorporated into this resolution as if set forth at length herein; and

WHEREAS, the Township Council of the Township of Howell finds it would be in the best interest of the residents and taxpayers of the Township to authorize the execution of the Shared Services Agreement with the Township of Colts Neck in substantially the form annexed hereto and made a part hereof;


NOW, THEREFORE, BE IT RESOLVED by the Mayor and Township Council of the Township of Howell, County of Monmouth, as follows:

1. That the appropriate officials be and are hereby authorized to execute the Shared Services Agreement with the Township of Colts Neck for the use of certain road equipment owned by Howell Township in substantially the form of the Shared Services Agreement annexed hereto and made a part hereof;

2. The Township Clerk is hereby directed to forward a duly certified copy of this **Resolution to the Township Manager, Director of Public Works and the Township of Colts Neck.**
