AUTHORIZING THE MAYOR AND MUNICIPAL CLERK TO EXECUTE A SHARED SERVICES AGREEMENT BETWEEN COLTS NECK TOWNSHIP AND THE BOROUGH OF WEST LONG BRANCH FOR TAX COLLECTOR SERVICES

WHEREAS, Colts Neck Township, a municipal corporation of the State of New Jersey, with principal offices located at 1 Veterans Way, Colts Neck (hereinafter the "Provider") desires to enter into a shared services agreement for the provision of Tax Collector Services with the Borough of West Long Branch (hereinafter the "Recipient") a municipal corporation of the State of New Jersey, with principal offices located at 965 Broadway, West Long Branch, NJ; and

WHEREAS, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-1 et seq. (the "Act") authorizes local units to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive in its own jurisdiction; and

WHEREAS, the Recipient is in need of the services of a person to perform the duties of Tax Collector, as set forth in the Agreement; and

WHEREAS, the Provider has agreed to furnish to the Recipient the services of Tax Collector pursuant to N.J.S.A. 40A:9-141 and N.J.S.A. 40A:65-1 et seq; and

WHEREAS, it is in the best interest of the citizens of Colts Neck Township and the Borough of West Long Branch to enter into the annexed Agreement.

NOW THEREFORE BE IT RESOLVED by the Township Committee of Colts Neck Township that it herby approves and authorizes the Mayor and Municipal Clerk to sign a Shared Services Agreement between Colts Neck Township and the Borough of West Long Branch for Tax Collector Services.
